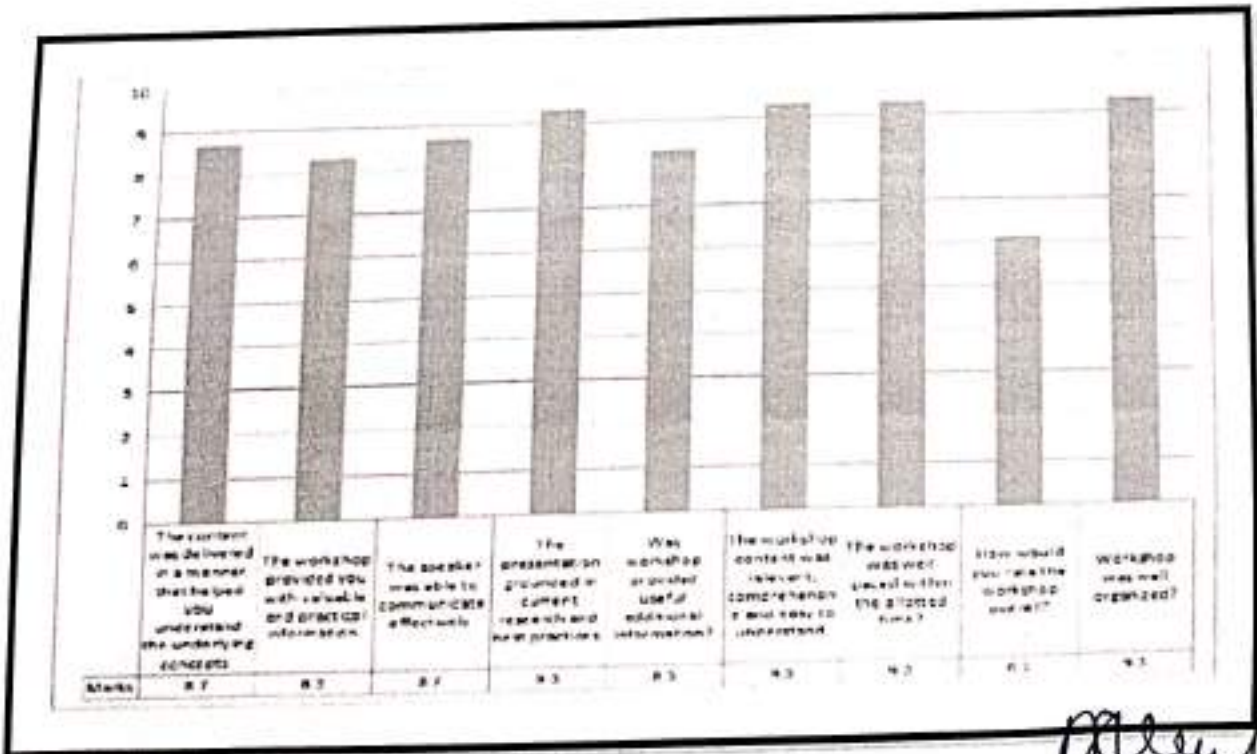

"RESEARCH METHODOLOGY"

Date: 26/04/2021 to 03/05/2021

Activity: One Week FDP on "Research Methodology"

Objective & Aim:

The Research Methodology Faculty development program is one of the most demanding program in the field of Education that would help our faculties to gain insight on developing Research Areas. Our objective is to conduct training for faculties for 7 days (4 sessions/Day) containing theory as well as hands-on training on different research software's and tools which would help faculties make use of this knowledge in doing effective Research.

Summary report of the Activity:

Following Research Methodology were covered day-wise through hands-on sessions:

Day 1: The importance of research in Teaching for teachers and Scholars was discussed "Quick Review of Research Process, Measurement and Formulating Objective/Hypothesis". Types of Research and Hypothesis testing were covered. Also, a case study related to model building was conducted.

DAY 2: "Introduction and Basics of R Statistical Software Package" in which the importance and relevance of R compared to other software packages was discussed. He further conducted hands on session by introducing and running basic commands.

"Overview of the Multivariate Research Techniques" explaining the steps and key considerations in conducting Multivariate analysis were conducted.

DAY 3: "Measurement Scales", Different types of measurement scales were discussed in the session namely: Nominal measurement, ordinal data; interval scale were discussed. He introduced the SPSS Statistics software for data with basic functionalities and data management (data view, variable view and output window) of SPSS software.

DAY 4: Measurement and Formulating Objective/Hypothesis, Hypothesis testing. He described the concept of Null Hypothesis to the participants, variable identification; and finally searches

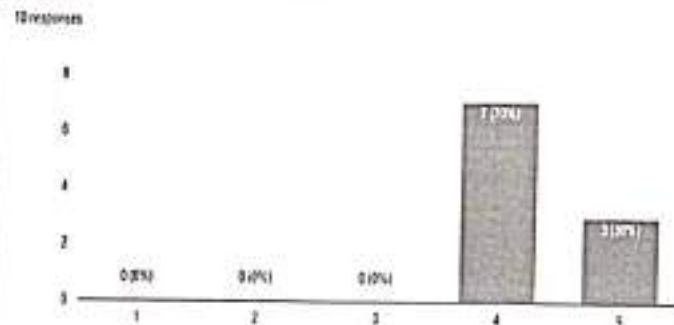
for the measurement model and test techniques were discussed.

DAY 5: Various sources of academic information on the web via YouTube, Google groups were discussed. He also briefed on how to connect with research scholars in the same area via Academia and LinkedIn, The concept of regression was explained. The participants then did hands on session for regression on SPSS software.

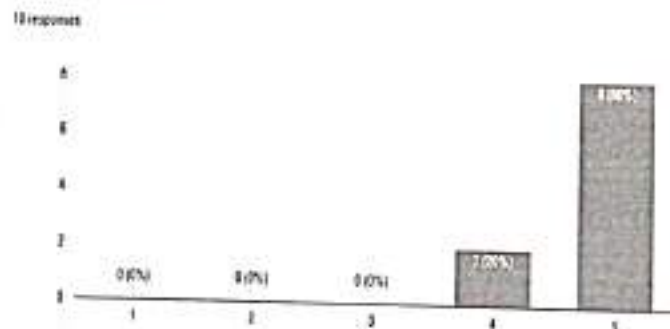
Day 6: The concept of multi co linearity being discussed with special reference to real life examples. He started the discussion on the concept of Cronbach's alpha and its relevance when using Likert Scale. Some important rules for applying exploratory factor analysis were discussed. The resource person demonstrated the Factor analysis on SPSS software.

Day 7: 'How to impute the finalized and fully validated model from the software', was discussed. Then the modifications indices techniques were taught in the validated model to improve it further. "Publication of Research Papers in Indexed Journals" with the focus on right works to publish in appropriate journals.

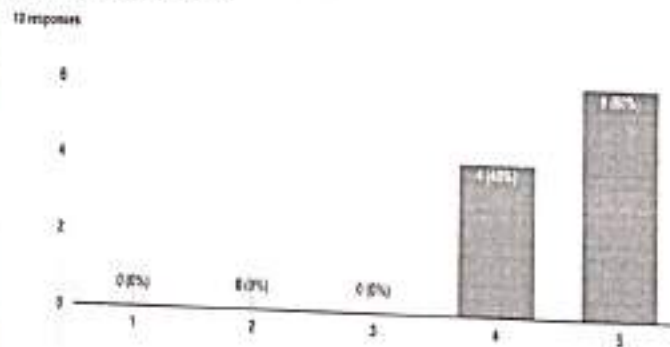

Overall feedback about the FDP

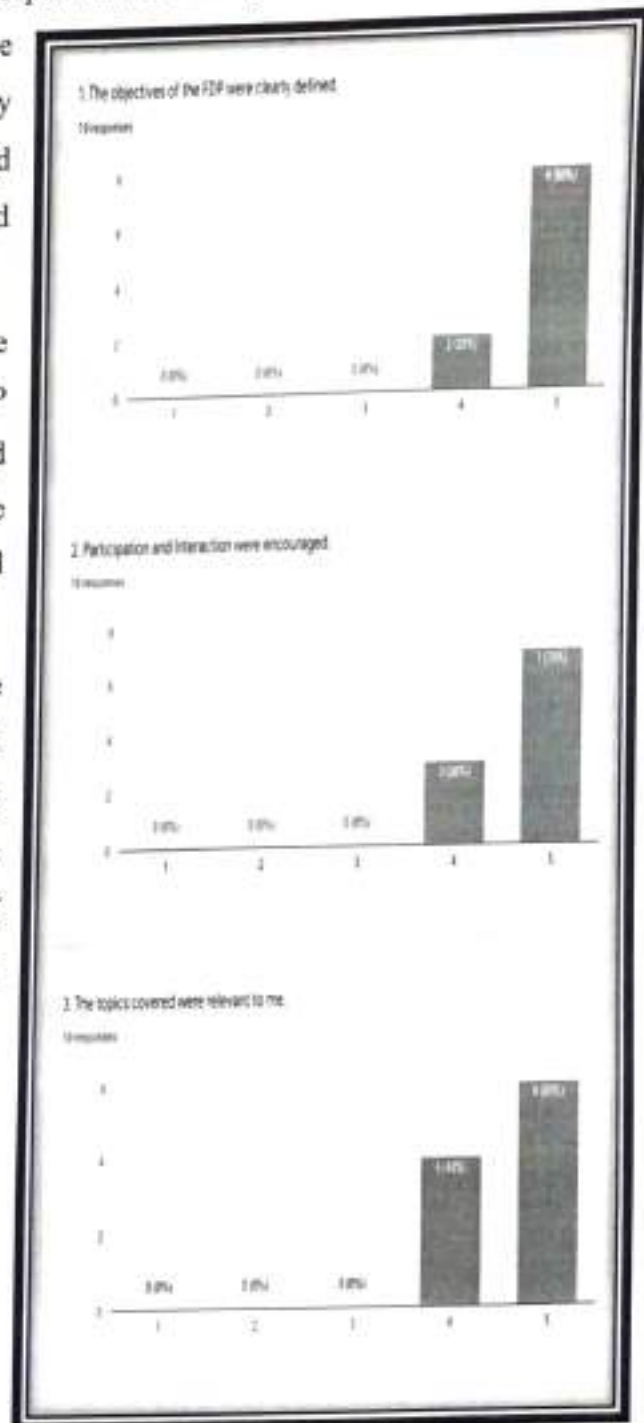


### Activity Processing (Analysis):

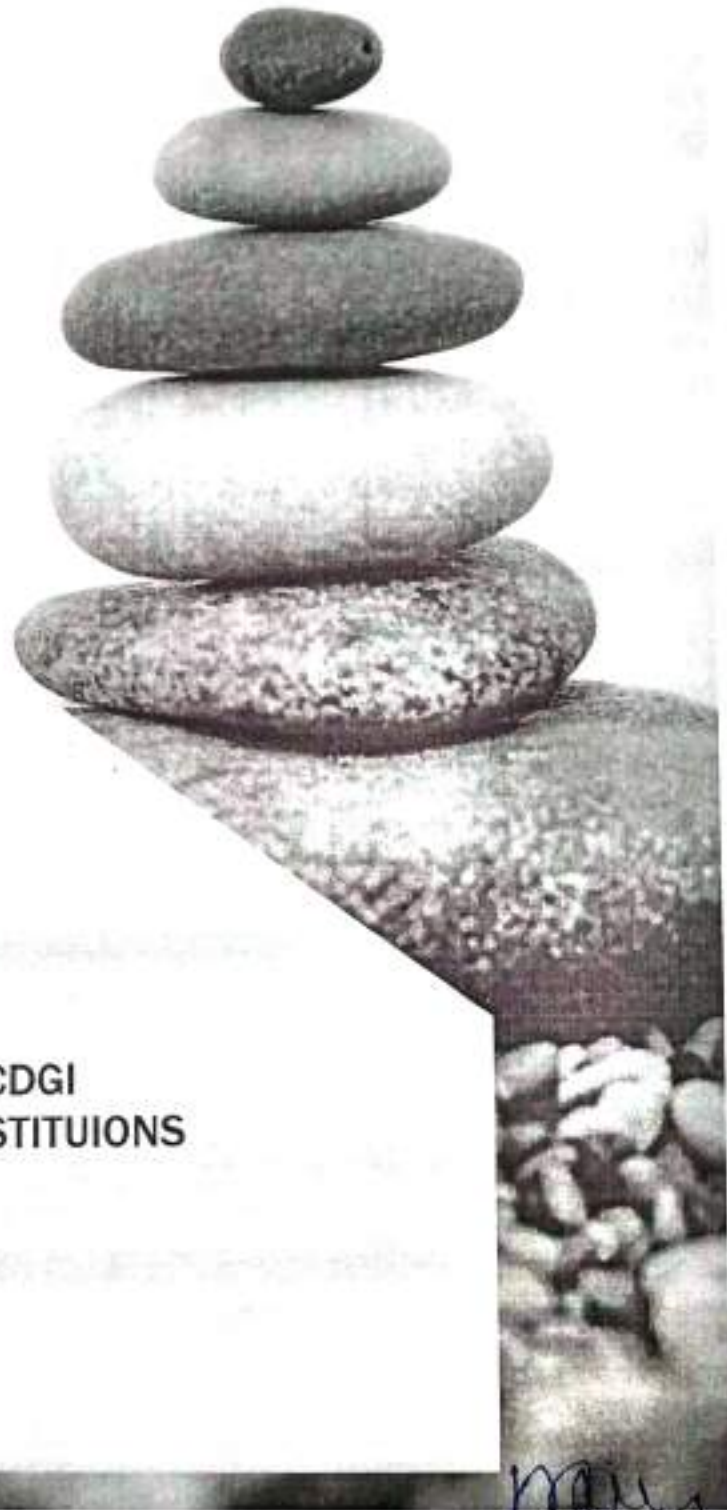

I-fame also works towards:


- Inculcating the entrepreneurial culture into the minds of students.
